Cannabinoid Methodology: High Performance Liquid Chromatography (HPLC) using Pesticide Free (PF) with Photo Diode Array Detector (PDAD). Total CBD and total THC are calculated values. To account for associated uncertainty from the analysis, THCA or CBDA to be reported, leaving weight loss of the acid group. These values are calculated as follows:
 Total THC = (THCA x 0.877) + Δ8-THC Total CBD = (CBDA x 0.877) + CBD
 Note: Total THC = 100% for all samples Report ID: C221107AO
 LOD = The lowest quantity that this method can reliably detect. Any cannabinoid that was not detected is assumed to be less than the stated LOD value.
 All results reflect dry weight of material, based on % moisture of the sample.
